No required Textbook: Most of our topics will have related reading material on the web or handouts. Reference source: 2010 Field Crop Scouting Manual – A Guide to Identifying and Diagnosing Pest Problems, Publication of University of Illinois Extension, College of Agricultural, Consumer and Environmental Sciences. This text has a couple of sections of common agricultural pests. However, the entire text will not be used. Other resources will include websites about entomology and agriculture.

**Course Objectives:** By the end of this course students should have a better understanding of insect classification, identification, morphology, life cycles, life processes, numerous insects common to crop production (pests and beneficial) and management considerations of insects important to agriculture.

**Lecture Topics:** classification and identification, life cycles, external morphology, internal anatomy, life systems, insect orders important to agriculture, and control strategies of agricultural insects and closely related pests, predators & parasites.

**Lab Exercises:** Lab will often meet Face to face in Knoblauch Hall, We will try to spend more time outside than inside while the weather holds. I may be able to arrange a field trip or two on campus, at the WIU farm, and at Allison organic farm to examine/collect insects, insect damage on various crops and livestock as well as evaluation and strategies for management. Insect morphology will be studied for ID.

**Insect Collection:** Students will be required to create an insect collection for this course. (100 pts) Project details will be presented in lab. Several collection opportunities will happen during lab, but some collecting on your own will be required to complete your collection.

**Insect Presentations:** Students will also be required to research, create and present four individual presentations (totaling 100 pts) and a group presentation on an insect management topic (50 pts for each individual in group).

# Policy on Face Coverings in the Classroom

All students and faculty are required to wear a face covering at all times in the classroom. Western Illinois University will provide two (2) cloth face coverings to all instructors and students, and replace them when necessary. Individuals may use a personally purchased alternative face covering as appropriate. Employees and students are responsible for laundering their reusable cloth face coverings. It is the responsibility of University units to ensure compliance from employees and students under their purview. # Disciplinary Policy on Refusal to Wear a Face Covering

Exceptions to the policy require approval by WIU's Disability Resources Center (DRC) located within the Student Development and Success Center (SDSC) and the Office of Equal Opportunity and Access.

# WIU Policy on Taking Attendance and Seat Assignments (COVID-19)
