*The College of Business and Technology is preparing the next generation of business and technology innovators to thrive in an evolving, interconnected global economic environment.*

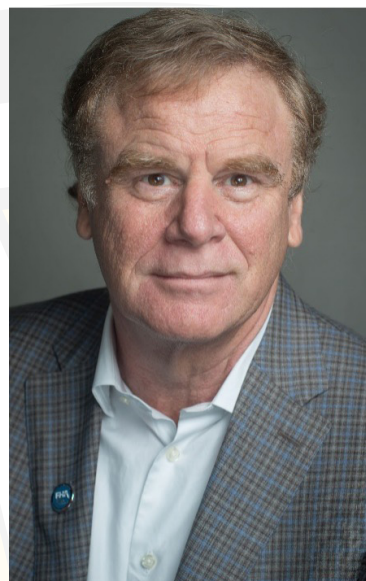

Prior to that, Mr. Kolosky served as the Executive Vice President/Chief Operating Officer of Moffitt Cancer Center in Tampa, FL, and served as the President of Moffitt Hospital. He joined the Cancer Center in November 1999. Mr. Kolosky has more than 30 years of health care leadership experience, including multiple hospital environments, clinical and academic settings, and tertiary health care delivery systems. Prior to Moffitt, Mr. Kolosky served as the Chief Financial Officer for the Georgetown University Medical Center in Washington, D.C., and as the Associate Vice President and Chief Financial Officer of the University of Texas M. D. Anderson Cancer Center in Houston, Texas.

Mr. Kolosky received his bachelor's degree in Accounting from Western Illinois University and an MBA in Finance from Drake University. He holds a Certificate from the Harvard University School of Public Health and is a Certified Public Accountant.

Mr. Kolosky is a Fellow in the Healthcare Financial Management Association, a member of the American College of Healthcare Executives, and is active in several other professional organizations. He served on the Board of Directors of Moffitt Genetics Corporation (M2Gen), the Tampa Bay Partnership, Nevada Cancer Institute, and was the Chair of Chapters Health System (the parent corporation of LifePath Hospice).
