  - Welcome

5. ERP implementation – (Stacie Hunt)
  - Slate
    - Admissions and Enrollment: We're continuing to work on the Admissions and Enrollment implementation of Slate. We hope to be able to go live sometime before the start of summer term.
    - Application Status Custom Portal: We came to the end of our contract with Carnegie to help us build a custom application status portal. They helped us build a portal for applicants, admitted students and denied students for Undergraduate and Graduate students. We are now building out the portal to accommodate International, BGS and reentry students. We hope to go live with this portal at the same time as the Admissions and Enrollment module.

- Advancement: We came to the end of our contract with Carnegie to help us build the foundation of the Advancement module. We continue to work to build out the functionality. We hope to be able to go live sometime in the fall semester.
    - Student Success: We started the implementation project with Carnegie to build the Student Success module. We have a 6 month contract with Carnegie. Our plan is to build out communications for our currently enrolled students.
  - Regent Education
    - Phase 1 Launch: We hope to be able to have award letters available to our new incoming students by the end of May, 2024 for the 24/25 academic year.
    - Phase 1A Launch: Our goal is to have award letters out to our existing students by the end of July, 2024.
    - Phase 2 - Disbursement: We plan to have financial aid disbursements out to students by late August, 2024
  - Ellucian Colleague
    - We have completed all of the Discovery Sessions with our Ellucian consultants. They have evaluated all of the information they gathered in the discovery sessions and have developed a proposed implementation timeline for the Financial System, Human Resources/Payroll system and Student Information system. Our first go-live is the Financial System scheduled for around July 1, 2024.
